Dave, as an avid golfer, loved his retirement party at Top Golf! We celebrated, reminisced, and created memories that will last a lifetime.

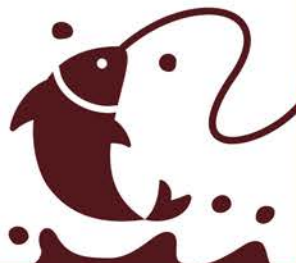


TAXWARE TEAM SPOTLIGHT
